Consent & Declaration Form



The organisers, Hockley Airsoft Arena Ltd, cannot take responsibility for any injury or loss/damage to personal property whilst on the site. All participants must read and sign the following agreement before commencement of play to show they fully understand and will abide by the site rules.

SITE RULES please read carefully:

- No physical contact between players; pushing, barging or other aggressive physical behaviour toward other players or staff will not be tolerated.
- Protection for eyes must be worn at all times in the airsoft arena. Under our insurance eye protection **must** be either a **full face mask** or **close fitting goggles**. Shooting glasses are **not** permitted in the arena.
- Any player caught removing eye protection in the play area will be asked to leave.
- Airsoft operates an honesty based system, players who are hit are expected to raise their hand and comply with game requirements.
- Any player shooting a player who has their hand raised can be automatically disqualified and asked to leave the gaming area.
- Pyrotechnics are strictly forbidden. CO₂ grenades are only hired to over 16s. Impact green gas grenades can be hired to all players.
- Ricochets do not count as hits, but any other hit does, whether it is on your equipment or little finger.
- All weapons must be made safe before entering the safe zone and must remain safe until you leave it. Magazines must be removed and the gun fired down the arena to empty.
- Suitable footwear must be worn. For example soft soled boots or trainers. Footwear must cover the foot including the toes. High heels, flip-flops and sandals (with or without socks) are not permitted, nor are leather or hard synthetic soles. Soft soles reduce the risk of slipping on BB's.
- Arms and legs must be covered; even in hot weather (the arena is air-conditioned). Wearing gloves is advised.
- No climbing or running within the arena. Anyone seen running will be given a verbal warning the second time you will be asked to leave the gaming area. 3 quick steps to get behind cover is not running, any more than that and it is.
- Do not shout out at anyone you think is not taking your hits, inform a marshal.
- No spray and pray, if you cannot see your opponent you should hold fire until you can. All shots should be aimed using the sights.
- Do not under any circumstances move or interfere with furniture.
- In the event of a fire move to the nearest fire exit and make your way to the front of the building where staff will meet you.
- For health and safety reasons chewing gum within the arena is not allowed, nor is the sucking of boiled sweets or holding anything else within the mouth which may cause choking. No food or drink is allowed within the play area. Any player seen chewing will be asked to leave the arena area.
- For health and safety reasons spitting within the arena will not be tolerated. Any customer seen by a member of staff or recorded on CCTV spitting will be asked to leave the premises immediately without a refund.
- Participants seen shooting the ceiling tiles or lighting deliberately will be charged £7.00 per tile/light.

This list of rules is by no means exhaustive if the marshals or staff witness unsafe play or it is reported by another player appropriate action will be taken up to and including exclusion.

Declaration:

I declare I am suitably fit to participate in the sport of Airsoft CQB at *Hockley Airsoft Arena Ltd*. I do not have any existing injuries or illnesses that will endanger me or others while participating in airsoft games. I will bring any pertinent conditions to the attention of the Hockley Airsoft Arena Ltd marshals at each and every game I attend while this document is in place. These include but are not limited to: asthma, heart conditions, diabetes, epilepsy, physical disability, hearing conditions and eye conditions.

I agree to adhere to the rules whilst playing at *Hockley Airsoft Arena Ltd* and understand that I alone take full responsibility for any loss/damage to property or personal injury whilst playing at *Hockley Airsoft Arena Ltd*.

By signing this declaration you are agreeing you have/will:

- a) Listen and adhere to the safety briefing regarding the risks involved and the site rules.
- b) Accept these activities are dangerous and can result in death, minor and/or serious injuries.
- c) Accept the risks and are responsible for your own actions &/or involvement.
- d) Disclose any medical condition which may be affected by playing and carry any necessary medication to treat if necessary.
- e) Give permission for first aid trained staff to administer any necessary first aid, call emergency services and/or next of kin if necessary.
- f) Understand that I give full permission for Hockley Airsoft Arena Ltd to use any video footage taken by me whilst on the premises, which I subsequently upload to the internet, in any of their marketing campaigns.

This document is valid for 12 months any changes to the conditions will be clearly displayed on site; it is the player's responsibility to check for any rule changes during that period. It is the player's responsibility to inform Hockley Airsoft Arena Ltd if there are any changes to their health which could potentially affect their play or others. After 12 months have lapse a new form is to be signed and this form shall be archived for a period of 3 years in accordance with guidelines provided by the insurer, conforming to GDPR regulations.

Data Protection:
